

### **Card on Corpay Complete**

#### Completed Work Stories 🖶

#### Description

**VCAP Report Contact Filter -** When creating a VCAP report, users can now filter by contacts manually entered in the Issue Virtual Card form using a freeform text field, rather than being limited to a dropdown list of Corpay Complete users. This update allows users to enter a contact name or issued-to name in the Issued To field, and the downloaded report will be filtered accordingly. This enhancement improves user experience by providing more flexible and accurate report filtering options.



**Merchant Data Collection -** Card users can now report on additional merchant data for their card purchases, including Merchant Address, Postal Code, and Country, in addition to the existing Merchant City and State. Integrations have been updated to collect this data for each transaction, and these fields have been added to the Virtual Card Reconciliation - Transactions report. This enhancement improves user experience by providing more detailed and comprehensive transaction information, making it easier to analyze and report on merchant data.

#### Completed Bug Fixes 🗶

#### Description

**VCAP Card Form Data Issues -** Fixed a bug where virtual cards couldn't be created if the associated employee's mobile number was in the wrong format. This fix ensures smooth card creation, improving user experience by preventing errors.

**VCAP Vendor Name Filter -** Fixed a bug where users were unable to filter by Vendor name for virtual cards on the All Cards grid, Transactions grid, and Create Report form for the Virtual Card Listing Detail and Virtual Card Listing Summary reports.

**Dashboard Transaction Display Fix -** Resolved an issue where authorized transactions were incorrectly displayed in the New Authorized Transactions section of the card dashboard. This fix ensures accurate transaction display, enhancing user experience by providing reliable information.

**VCAP Report Download Errors -** Fixed a bug that caused errors when downloading certain VCAP reports in XLSX format. This update ensures successful report downloads, improving user experience by providing reliable access to data.

**Mid-Cycle Card Limit Refresh -** Addressed an issue where mid-cycle card limits were not refreshing correctly on the reset date. This fix ensures accurate limit updates, enhancing user experience by maintaining correct card limits.

**Pending Transactions Button Fix -** Fixed a bug where the "View All Pending Transactions" button on the New Pending Transactions widget did not work. This update ensures functionality, improving user experience by providing access to pending transactions.



### **Expense on Corpay Complete**

#### Completed Work Stories 🖶

#### Description

Attach Queued Receipt Option - Expense module users can now attach an available receipt from the Receipt Queue when creating or editing an expense item on the web, similar to the mobile app. When users click the Upload Receipt button, a new tab called "Available Receipts" will show a list of unmatched receipts from the Receipt Queue. If a queued receipt is deleted, it returns to the Receipt Queue. The receipt list is sorted by date in descending order, and any receipt note entered will be applied to the Description field. This update improves user experience by providing a consistent and efficient receipt attachment process across both web and mobile platforms.



### Completed Bug Fixes 🗶

#### Description

**GL Coding Edit Fix -** Resolved an issue where edits to GL coding on the Expense Report Details page were overwritten. This fix ensures that GL coding edits are retained, enhancing user experience by maintaining accurate expense data.

**Create Expense Item Button Fix -** Fixed a bug where the Create Expense Item button was hidden for newly created companies. This update ensures functionality, improving user experience by providing access to expense item creation.



### **Mobile App on Corpay Complete**

#### Completed Work Stories 🖶

#### Description

**Approval Workflow Section -** Corpay Complete mobile app users can now see where their expense report is in the approval workflow on the Expense Report Details page, similar to the web version. The Approval Workflow section has been added to this page for all expense reports that have started the approval process. This update improves user experience by providing clear visibility into the approval status, making it easier to track the progress of expense reports.



**Metadata Fields Dropdown Filter -** In the mobile app, the "simple picker" for metadata fields on expense items, which previously displayed only the most recent 25 records without search functionality, has been upgraded to a "searchable picker." This enhancement, already available on the web, enables users to search and access more than just the initial 25 records. This update enhances user experience by offering a more efficient and comprehensive method for selecting metadata fields.

#### Completed Bug Fixes 🗶

#### Description

**Route Map Improvements -** Fixed a bug where the address text box for Destination E overlapped the Round Trip checkbox on mileage route maps. Added validation to prevent incomplete route maps. This update enhances user experience by ensuring accurate route mapping.

**Duplicate Receipt Notifications Fix -** Resolved an issue where duplicate receipt required notifications were sent for some transactions. This fix improves user experience by preventing redundant notifications.

**Approval Request Display Fix -** Fixed a bug where expense report approvals did not appear in the Approvals list. This update ensures visibility, improving user experience by providing access to approval requests.

**Message Display Fix -** Fixed a display bug where success and confirmation messages appeared in the middle of the screen instead of at the bottom. This update enhances user experience by ensuring consistent message placement.


**Android Shadow Effect Fix -** Resolved a display issue on Android devices where a shadow effect appeared incorrectly on approval icons.

**Mileage Expense Item Crash Fix -** Fixed a bug causing the app to crash when editing mileage expense items. This update enhances user experience by ensuring app stability.

**Swipe Edit Expense Item Fix -** Resolved an issue where the app crashed when swiping to edit an expense item. This fix improves user experience by ensuring smooth editing functionality.

### Invoice Automation and PO on Corpay Complete

#### Completed Work Stories ==

#### Description

**Invoice and PO Metadata Display -** With this update, custom fields on the Invoice and PO Line Items in the PO matching tab of the invoice inbox were exposed. This enhancement improves user experience by allowing users to compare custom fields when matching.



**PO Item Metadata Display -** PO item metadata is now displayed in the receiving module, ensuring that if metadata is used on the PO, the values are shown on the receipt as well. These fields are display-only and cannot be edited, maintaining consistency with the PO. This update provides users with all relevant data for review, enhancing user experience by offering comprehensive context for each receipt.

**Invoice Listing Report Optimization -** With this update, the Invoice Listing Report was optimized to allow users to pull more results into the report. This enhancement improves user experience by providing comprehensive report data.

#### Completed Bug Fixes 🗶

#### Description

**Error Message Display Fix -** Resolved an issue where the "Oops, something went wrong please contact Support" error message was displayed in the Invoice Inbox.

**Due Status Column Fix -** Fixed a bug so filtering and sorting work on the Due Status column.



### **Payments Automation on Corpay Complete**

#### Completed Work Stories 🖶

#### Description

**Vendor and Location IDs Addition -** With this update, additional Vendor and Location IDs were added to the Payment Details view. This enhancement improves user experience by providing more detailed and specific payment information.



**Payment Level Approvals -** AP Complete customers now have the option to enable payment level approvals, in addition to Payment Run approvals. This update provides customers with the flexibility to approve payments individually, enhancing user experience by allowing more granular control within the batch approval process.

#### Completed Bug Fixes 🗶

#### Description

**Check Number Filter Fix -** Fixed an issue where the check number filter was not functional on the Payment Grid. This update enhances user experience by ensuring the filter works correctly, allowing for more efficient data sorting.

**Negative Amount Payments Fix -** Resolved an issue where payments with negative amounts were created if a discount was automatically applied and a credit memo was manually applied. This fix ensures accurate payment processing, enhancing user experience by preventing incorrect payment amounts.
